# Top 100 cited articles in the field of rheumatology

To the Editor,

As there is a vast amount of rheumatological literature in the past years, we aimed to analyze the top 100 cited publications in journals in the field of rheumatology (1, 2).

We retrieved all articles indexed in the field of rheumatology in Web of Science® as of September 2016. Articles that were not within the top 100 most-cited publications were then excluded. We extracted data on title, first author, year, type of research (clinical or basic research), country, journal name, total citation (TC), and citation rate (CR). Data, such as gross domestic product (GDP) and population, were extracted from the World Bank Database base on the address of the corresponding author (3). TC was defined as the total number of citations from the time of publication up to September 2016, while CR was defined as TC divided by the number of years the article was published up to 2016. We calculated TC per billion GDP, TC per million population, CR per billion GDP, and CR per million population. We conducted multivariable linear regressions with publication year and type of research as independent variables and TC and CR as dependent variables. State SE 14.0 was used and p<0.05 was considered statistically significant.

The top cited article was "The 1982 Revised Criteria for the Classification of the Systemic Lupus Erythematosus." The top 100 articles were from 12 countries and with the USA as the top country (n=70). After adjusting for population, USA remained as the top. After adjusting for GDP, UK became the top country for TC. The top journal in the first 100 cited articles was Arthritis and Rheumatism (n=23). The top 100 articles' list, ranking of TCs of articles sorted by countries and journals are presented in Table 1, S1, and S2, respectively. There were 26 basic science papers and 74 clinical research papers. From the multivariate analyses, there was no difference in the outcome variables associated with types of research. Publication year has an association with CR ( $\beta$ : 2.83, p<0.01) but not with TC ( $\beta$ : 14.03, p=0.25). The above findings were similar to that presented by Ahmad et al(4) in the field of orthopedics, whereby it shows publication year does not affect TC but affects CR. A main limitation of this study was that we did not adjust for the effect of articles that were published as diagnostic criteria as these articles were considered clinical study-related because they consolidated consensus and literature to generate guidelines for diagnoses. However, the intention of this letter was to show readers the types of articles that were most cited; hence, this should not affect the primary aim.

In conclusion, the top 100 cited articles in rheumatology were analyzed in this article. We showed the gap in research in locations other than the UK and USA. The types of research conducted were neither associated with TC nor CR. Publication year was associated with CR but not TC.
